CREDIT FACILITY CONDITIONS (which form part of our Business Terms & Conditions)

Stagepoint Group (Stagepoint Technical Services Ltd & Stagepoint Productions Ltd) hereafter referred to as "Stagepoint" offers the credit facility conditions upon the following terms.

1. The credit facility is available to customers to anticipate an annual expenditure with Stagepoint of over £1000 (excluding VAT). This amount may vary at the discretion of Stagepoint. The credit facility may be withdrawn if the total expenditure is less than the stipulated amount.
2. The credit facility shall apply for an initial period of three months and provided that Stagepoint are satisfied as to the prompt settlement of accounts and trade references, shall continue to operate until terminated by either party.
3. Payment shall be made in Pounds Sterling (or Euros if the account has been initiated on this basis) in the United Kingdom by cheque, bank transfer or other such method as Stagepoint may reasonably require.
4. Terms are thirty days from the date of invoice. In the event of non-payment within our contract term, Stagepoint reserves the right to charge interest on the account at the rate of 2% per month from the due date to the date of payment.
5. The title to any goods supplied for sale remains with Stagepoint until payment for the goods has been received in full.
6. In the event of the issue of legal proceedings for the recovery of any outstanding debt, the customer will be liable for all charges incurred in connection with the recovery.
7. Stagepoint shall not be obliged to supply any products or services if the customer's account is overdue or exceeded.
8. The credit facility is personal to the customer and for their use only
9. The customer shall not exceed the given credit limit at any time without prior notice and arrangement.
10. The credit facility may be withdrawn by Stagepoint at any time and any sums owing to Stagepoint shall become due and payable with immediate effect.
